Our Development and Future

Our company was founded on May 1, 1960 as «Treuhand- und Revisionsgesellschaft Walter Suter & Co.» with Head Offices on the Bahnhofstrasse in Schwyz.

The following stages mark the development of our enterprise:

- The Beginning The start was modest. The joint founder Alfred Suter describes the beginnings thus: «Chairs brought from home provided us with seating at two old desks which our landlord, Credit Suisse, donated to us, and on which a full workload rapidly accumulated. Right from the very beginning there was no shortage of clients.» Within a year of the start-up the company was already employing a trainee and an accountant. The enterprise grew steadily, and in 1972 we relocated to Bahnhofstrasse 28.
- Succession With the departure of Alfred Suter, who as limited partner had contributed decisively to the development of the company since its foundation, the arrangements governing succession were introduced. The taking on of long-standing members of staff as limited partners, and Dr. Franz Mattig as general partner created a necessary name change. From then on the company was known as «Treuhand- und Revisionsgesellschaft Suter, Mattig und Partner». This decision laid the basis for the future.
- Regeneration Following the death of the company founder Walter Suter on February 23, 1992, a second name change took place. Since then we have been known as «Treuhand- und Revisionsgesellschaft Mattig-Suter und Partner». It continues to be a limited partnership in which long-standing staff members have stakes as limited partners, and Dr. Franz Mattig as general partner.
- Future We are safeguarding our corporate independence as a highly-qualified specialist company. We believe cooperation with other strategic partners is the key to our company's sustained development. Through these relationships we benefit in the form of expansion, enhancement and global networking.
